Waiver, Release and Hold Harmless Agreement

I _____ as the undersigned parent/legal guardian, the undersigned, of _____ a minor (the child), hereby consent to my child's participation in all events sponsored by Largo United Soccer Club, including but not limited to Tryouts, Training sessions, practice or any other activity or event sponsored by the Largo United Soccer Club and use of the City of Largo's facilities located at 1779 So Belcher Rd, Largo Florida. The undersigned acknowledges that on or about March 11, 2020, the Novel Coronavirus Disease 2019 (COVID-19) was declared a pandemic by the World Health Organization and that the Center for Disease Control and Prevention (CDC) have stated the "best way to prevent illness is to avoid being exposed to this virus."

The undersigned is aware of the highly contagious nature of COVID-19 and voluntarily chooses and chose to allow the child to participate in any and all activities sponsored by Largo United Soccer Club in light of the ongoing COVID-19 pandemic.

The undersigned acknowledges that Largo United Soccer Club independent contractors, volunteers, coaches, executive director and board members come into contact with multiple individuals every day and may become exposed to COVID-19 in various ways and situations. While Largo United Soccer Club takes precautions to reduce the likelihood of transmission of COVID-19 by its independent contractors, volunteers, coaches, executive director and board members, the undersigned acknowledges that Largo United Soccer Club will not and does not guarantee that the child will not be exposed to or infected with COVID-19.

The undersigned acknowledges and agrees that by allowing the child to participate in any and all events sponsored by Largo United Soccer Club, the undersigned is exposing the child and the undersigned, to the risk of becoming exposed to or infected with COVID-19, which may result in personal injury, illness, permanent disability and death. The undersigned understands that the risk of becoming exposed to or infected by COVID-19 may result from actions, negligence, and failure to act of the undersigned or others, including but not limited to Largo United Soccer Club and other Largo United Soccer Club participants, parents, coaches, volunteers, executive director and board members. The undersigned assumes all risks and hazards and accepts personal responsibility for the undersigned and child for any injury, illness, damage, loss claim, liability or expense, of any and all kind or nature that the undersigned or child may suffer arising out of or in connection with the undersigned or child's exposure to or infection by COVID-19 and the child's participation in any and all events sponsored by Largo United Soccer Club.

On my own behalf and on behalf of the child, I hereby waive, release, absolve, commit not to sue and forever discharge Largo United Soccer Club, its board of directors, executive director, coaches, volunteers, agents, servants, representatives, attorneys, and or any other person , firm or corporation charged or chargeable with responsibility with Largo United Soccer Club, from any and all liabilities, claims, demands, damages, expenses including but not limited to reasonable attorneys' fee and costs, actions, loss or injury of any kind whatsoever, including personal injury, illness, bodily injury, death and or property damage (Claims), arising out of or in any way connected with the child's participation in any and all events sponsored by Largo United Soccer Club, the child's exposure to or infection by COVID-19 and my exposure to or infection by COVID-19. I understand that this release includes any claims base on

the negligence, action or inaction of any of Largo United Soccer Club, its board of directors, executive director, coaches, volunteers, agents, servants, representative, attorneys, and or any other person, firm or corporation charged or chargeable with responsibility for events sponsored by Largo United Soccer Club and cover bodily injury (including death) due to COVID-19, whether a COVID-19 infection occurs before, during or after participation in any and all events sponsored by Largo United Soccer Club. Nothing contained herein shall be construed to be a waiver of any immunity or limitation of liability Largo United Soccer Club may be entitled to under the doctrine of sovereign immunity or section 768.28, Florida Statutes.

To assist the prevention of the spread of COVID-19, the undersigned agrees to complete the City of Largo's COVID-19 Screening Checklist on each day and at every event of the child's participation in any and all sponsored events by Largo United Soccer Club, prior to the child entering the City of Largo's facility located at 1779 So. Belcher Rd. Largo, Florida. The undersigned agrees to not bring the child to any and all events sponsored by Largo United Soccer Club or to any City of Largo facilities if the child or anyone in the child's household has been diagnosed with COVID-19, exposed to someone who has been diagnosed with COVID-19, or show any symptoms of COVID-19. The undersigned agrees to comply with all current CDC, City of Largo and Largo United Soccer Clubs' rules and guidelines for dealing with the COVID-19 pandemic at all times, including but not limited to while at home and while at any and all events sponsored by Largo United Soccer Club. Largo United Soccer Club reserves the right to take the child's temperature at any time, during any event sponsored by Largo United Soccer Club.

Largo United Soccer Club reserves the right to send any child home from any and all sponsored events when Largo United Soccer Club has any reason to believe the child may have been exposed to COVID-19, have COVID-19 or its symptoms, or the child does not comply with the CDC, City of Largo and Largo United Soccer Club's rules and guidelines for dealing with the pandemic. The undersigned agrees to notify Largo United Soccer Club immediately if the child or any member of the child's household is diagnosed with COVID-19 or is exposed to someone who has been diagnosed with COVID-19.

NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN:

READ THIS AGREEMENT COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF LARGO UNITED SOCCER CLUB USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICPATION IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS AGREEMENT YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM LARGO UNITED SOCCER CLUB, IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOU CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE PARTICIPATING IN ANY OR ALL EVENTS SPONSERED BY LARGO UNITED SOCCER CLUB. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS AGREEMENT AND LARGO UNITED SOCCER CLUB HAS THE RIGHT TO REFUSE TO ALLOW YOUR CHILD TO PARTICIPATE IN ANY AND ALL EVENTS SPONSERED BY LARGO UNITED SOCCER CLUB IF YOU DO NOT SIGN THIS AGREEMENT.

I, the undersigned, verify that all the information in this agreement is accurate and that I have read, understand, and agree to the terms and conditions herein, as well as all rules and regulations governing Largo United Soccer Club.

This waiver, release, and hold harmless is effective as of the date signed and returned to Largo United Soccer Club and shall continue indefinitely for every and all events sponsored by Largo United Soccer Club, except as otherwise noted herein. The undersigned represents and warrants that he or she is authorized to sign this waiver, release, and hold harmless on behalf of the child.
